1. The Embassy of India, Addis Ababa for and on behalf of President of India, invites lump-sum tenders for the following works:

2. Suppliers who fulfil the following requirements shall be eligible to apply. These criteria are indicative. Exact details are available in tender documents.

- Experience of having satisfactorily completed three similar works, each costing not less than **US\$ 1,45,000** or two works each costing not less than **US\$ 1,80,000** or one work costing not less than **US\$ 2,85,000** during the last 5 years ending January, 2022.
- Should have average annual financial turnover of not less than **US\$ 1,80,000** (excluding VAT) during last five years.
- Applicant should be profit making individual/company/firm and should not have incurred any loss in more than two years during the last five financial years. This fact should be duly certified by Chartered Accountant.
- Should have a bank solvency (Credit Facility) of **US\$ 1,45,000 (excluding VAT)** as per details in tender.

5. **Bid Security:** The Tenderer must submit with his Tender the Bid Security in the sum of **US\$ 7,200.00** or Indian Rupees or Ethiopian Birr [as per prevailing official exchange rate at the time of depositing the Security]. Bid Security shall be in the form of CPO in favour of Embassy of India, Addis Ababa. The other terms and conditions related with the Bid Security Declaration shall remain same as mentioned in the tender document.

The Bid Security shall remain valid for a period of One Hundred Sixty Five (165) days from last date of submission of tender.

6. Tender documents supported with prescribed annexures should be submitted in sealed envelope, as per the tender document. The document will be received up to 3.00 PM on March 11, 2022, and will be opened on the same day at 3.30 PM.
7. If any information furnished by the applicant is found incorrect at a later stage, he/she shall be liable to be debarred from the tendering process. The Embassy of India, Addis Ababa reserves its right to verify the particulars furnished by the applicant independently.
8. The Embassy of India, Addis Ababa reserves the right to reject any prospective applicant without assigning any reason thereof and to restrict the list of pre-qualified Suppliers to any number deemed suitable by it.
