3. Gratis Visas (All types of Visas)

Afghanistan, Bangladesh, Democratic People's Republic of Korea, Jamaica, Maldives, Mauritius and Mongolia

4. Seychelles: All types of visas except for work/employment are issued on gratis basis.

5. Argentina: Business, Tourist and Transit visas are issued on gratis basis. **Normal Visa fees are applicable for all other types of Visas.**

6. Uruguay: Tourist visas are issued on gratis basis. **Normal Visa fees are applicable for all other types of Visas.**

7. Visa Free Countries: Nationals of **Nepal** and **Bhutan** do not require visa to enter India. However, Nepali nationals require visa if they enter India from China, which may be granted gratis.

8. Pakistani Nationals: Visa fee for Pakistan nationals is Rs. 100. The visa fee payable in ETB is based on ORE of that month for an Indian visa of all types.

9. Special Visa Fee Categories:

a) Singaporean Nationals: The charges for Tourist visa (Multiple entry), valid for up to six months is US\$ 25. However, fee for all other type of visa will be same as applicable to other countries.

b) Japanese Nationals: The charges for transit visa is US\$ 1 and the charges for all other types of visa is US\$ 8.

c) South Africa Nationals: Short term visa for all categories (i.e. with validity upto 90 days) to South African nationals will be granted on GRATIS basis. Long term visas to South African nationals will be granted as per Annexure IV

c) U.K. Nationals: The fee for U.K. nationals for different types of visas will be as follows:
